### **Extent**

Approximately 2,684 photographs in color and black & white film processed from 35mm negatives.

### **Access**

Collection is open to all researchers. Access to Clinton Presidential Records is governed by the Presidential Records Act (PRA) (44 U.S.C. Chapter 22, as amended) and the Freedom of Information Act (FOIA) (5 U.S.C. 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

### **Scope and Content**

FOIA 2008-0666-F (Segment 9) is a request for all Clinton Administration White House photographs taken from July 1, 2000 through December 31, 2000.

The photographs processed in this segment were created from August 12, 2000 through August 14, 2000. The segment contains photographs pertaining to: arrivals, departures, meetings, ceremonies, photo-ops, etc., involving President Clinton, Hillary Rodham Clinton, Chelsea Clinton, staff and others for the time period processed. Of primary focus for this segment is photographs for the 2000 Democratic National Convention in Los Angeles, California.

**Photographs from August 12, 2000 are as follows:**

First Lady Hillary Rodham Clinton prepares for her speech at the Democratic National Convention at her hotel in Los Angeles, California. Present are Mark Penn, Lissa Muscatine and other speechwriters. Later the First Lady participates in various interviews in her hotel suite.

First Lady Hillary Rodham Clinton participates in an interview with CNN's Larry King at the Staples Center in Los Angeles, California.

**Photographs from August 13, 2000 are as follows:**

President William Jefferson Clinton greets individuals at the St. Regis Hotel in Los Angeles, California. The President later greets individuals along the motorcade route. Present is Doug Band.

President William Jefferson Clinton addresses a Jewish community celebration on the Sony Pictures Studio Main Street set in Los Angeles, California.

First Lady Hillary Rodham Clinton prepares & practices her speech for the Democratic National Convention at the Staples Center in Los Angeles, California.

**Photographs from August 14, 2000 are as follows:**

President William Jefferson Clinton prepares his speech for the Democratic National Convention in his hotel suite at the St. Regis Hotel. Present are Bruce Reed, Paul Glasris, Joel Johnson, and Jeff Shesol. Also present are Mandy Grunwald, Howard Wolfson, and Steve Ricchetti.

First Lady Hillary Rodham Clinton prepares & practices her speech for the Democratic National Convention in her hotel suite at the St. Regis Hotel.

President William Jefferson Clinton and First Lady Hillary Rodham Clinton attend the Democratic National Convention at The Staples Center in Los Angeles, California. The President and First Lady are photographed in their holding rooms prior to delivering their remarks. The President and First Lady deliver individual remarks. Numerous photographs of the various state's delegates are shown.

First Lady Hillary Rodham Clinton participates in separate interviews with Peter Jennings, Tom Brokaw and Dan Rather at The Staples Center.

First Lady Hillary Rodham Clinton attends separate events addressing the African-American Caucus, the New York Delegation, the Hispanic Caucus, and America's Women 2000.

**System of Arrangement**

Records that were responsive to this FOIA request were found in one collection area and one series—Clinton Presidential Records: Photographs of the White House Photograph Office and the series therein—Photographs Relating to the Clinton Administration. Processing is done at the Folder/Contact sheet level. While this method maintains folder/contact sheet integrity, it frequently results in the processing of photographs that are not wholly responsive to the subject area.
