Scope and Content

FOIA 2006-1135-F (Segment 109) is a request for all Clinton administration White House photographs taken in 1993.

The photographs processed in this segment were created December 4 through December 7, 1993. The segment contains photographs pertaining to: arrivals, departures, meetings, ceremonies, press briefings, interviews, photo-ops, etc., involving President Clinton, Hillary Rodham Clinton, and staff for the time period processed.

Photographs from December 4, 1993 are as follows:

President William Jefferson Clinton participates in a California Economic Roundtable at Rockwell International. Present include Secretary Ron Brown, Mayor Richard Riordan, and Senators Dianne Feinstein & Barbara Boxer, among others. Following the roundtable meeting, the President greets & addresses Rockwell employees and tours the facilities.

President William Jefferson Clinton participates in a luncheon at the Beverly Hilton Hotel.

President William Jefferson Clinton meets with the Los Angeles Times editorial board at the L'Escoffier Restaurant in Los Angeles, California.

President William Jefferson Clinton addresses a Democratic National Committee fundraiser at the Creative Artist Agency in Los Angeles, California. Present are Senator Dianne Feinstein and Secretary Ron Brown.

President William Jefferson Clinton departs Los Angeles en route to Andrews Air Force Base.

First Lady Hillary Rodham Clinton addresses a Zero to Three awards ceremony at the White House (Zero to Three is an early childhood development advocate organization) at the Washington Hilton Hotel. Present are Kathryn Barnard, President of the Board for Zero to Three, and Doctor Berry Brazelton.

First Lady Hillary Rodham Clinton attends a health care reform project meeting at the home of Senator Jay Rockefeller and Mrs. Sharon Rockefeller.

First Lady Hillary Rodham Clinton with the gingerbread White House. Present are White House pastry chef Roland Mesnier and assistant Franette McCullouch.

First Lady Hillary Rodham Clinton meets with Deane Shatz, Anna Perl and Lori Perl

Photographs from December 5, 1993 are as follows:

President William Jefferson Clinton and First Lady Hillary Rodham Clinton greet Kennedy Center honorees at the White House. The honorees are Johnny Carson, Arthur Mitchell, Sir George Solti, Stephen Sondheim, and Marion Williams. The honorees are commended at a ceremony in the East Room. Later, the President, First Lady, and honorees proceed to the Kennedy Center for a performance in the Opera House.

President William Jefferson Clinton and First Lady Hillary Rodham Clinton view Christmas décor in the White House following the events for the Kennedy Center honorees. The President and First Lady pose for photographer Kit Walling, whom is shooting the cover photograph for The Washington Post.

First Lady Hillary Rodham Clinton attends a reception thanking volunteers whom decorated the White House for Christmas. Present are florist Nancy Clarke, Ann McCoy, Ann Stock, and Capricia Marshall, among others.

Socks explores the White House and Christmas decorations.

Photographs from December 6, 1993 are as follows:

President William Jefferson Clinton and First Lady Hillary Rodham Clinton greet members of Extra Years of Zest (XYZ) following their tour of the White House. The President and First Lady meet with the members to discuss health care as part of "Senior's Day at the White House." The President and First Lady speak with staffers prior to the meeting including Julia Moffett, Jeff Eller, Mark Gearan, and Kelly Craighead, among others.

President William Jefferson Clinton and First Lady Hillary Rodham Clinton greets Prime Minister Felipe Gonzalez of Spain and his wife Mrs. María del Carmen Romero at the White House and participate in separate meetings. The President meets with senior staff including Tony Lake and Leon Fuerth prior to meetings with Prime Minister Gonzales. A breakfast meeting regarding health care is held in the Map Room. Following the arrival ceremonies and meetings a working luncheon is held in Blair House. Present include Jenonne Walker, Tony Lake, and Mark Gearan, among others.

President William Jefferson Clinton meets with David Gergen, George Stephanopoulos, Ricki Seidman, and Stephanie Streett for a scheduling meeting.

President William Jefferson Clinton meets with the Knight Ridder editorial board.

President William Jefferson Clinton greets Corbin Bernsen and Jeff Ballard at the White House.

President William Jefferson Clinton greets Kathleen Battle.

President William Jefferson Clinton listens to the Tower Saxophone Quartet at the White House.

President William Jefferson Clinton meets with Laura Tyson, Ron Brown, John Podesta, Gene Sperling, Leon Panetta, Alice Rivlin, George Stephanopoulos, Bowman Cutter, Roget Altman, and Alin Blinder, among others, regarding the budget.

First Lady Hillary Rodham Clinton greets the press during a press review of the 1993 Christmas decorations at the White House. The First Lady speaks on objects that make up the décor including the Gingerbread White House and Blue Room Christmas Tree.

First Lady Hillary Rodham Clinton tapes a television interview with WBZ-TV NBC.

Socks sits on the South Grounds at the White House.

Photographs from December 7, 1993 are as follows:

President William Jefferson Clinton participates in a budget meeting for the Environmental Protection Agency (EPA) and the Department of the Interior. Present are Secretary Bruce Babbitt, EPA administrator Carol Browner, Alice Rivlin, Alan Blinder, Howard Paster, Laura Tyson, Gene Sperling, and Leon Panetta.

President William Jefferson Clinton speaks on the telephone to President Kim Dae-jung of South Korea. Present is Samuel "Sandy" Berger.

President William Jefferson Clinton meets with New York City mayor-elect Rudolph "Rudy" Giuliani at the White House. Prior to the meeting the President confers with George Stephanopoulos, John Hart, and Marcia Hale.

President William Jefferson Clinton meets with Arkansas House of Representatives member Jon Fitch and his wife Mrs. Marian Fitch.
