Scope and Content

FOIA 2021-0260-F is a request for all photographs containing Oprah Winfrey. Oprah Winfrey produced and hosted the daytime talk show The Oprah Winfrey Show. In addition to her daytime talk show, Oprah has appeared in films, various television shows, and performed voice over work.

Records processed responsive to the case include photographs of President William Jefferson and First Lady Hillary Rodham Clinton with Oprah Winfrey. Events include President Clinton signing the Child Protection Act in 1993, the State Dinner for the Emperor of Japan at the White House, tapings of the Oprah Winfrey Show, the Philadelphia Summit Celebration of Service, a dinner honoring Dorothy Height, and President Clinton delivering phone remarks to The Oprah Winfrey Show.

Individuals present include Oprah Winfrey, President Clinton, First Lady Hillary Rodham Clinton, Secretary of Health and Human Services Donna Shalala, Senator Joe Biden, Representative Pat Schroeder, Dr. Berry Brazelton, Maya Angelou, President George H.W. Bush, Mrs. Barbara Bush, General Colin Powell, Alma Powell, Grover Washington, Jr., Harris Wofford, Jimmy Smits, Tony

Bennett, Wynton Marsalis, Savion Glover, John Travolta, Wynonna Judd, Brooke Shields, LL Cool J, Lyn Swann, Rasheen Coleman, David Atkins (“Sinbad”), Michael Bolton, Rob Reiner, Willye White, Patti LaBelle, Dorothy Rodham, Hugh Rodham, Nicole Boxer Rodham, Dorothy Height, Jesse Jackson, Jessye Norman, Susan Taylor.

Material processed as matter of consequence includes First Lady Hillary Rodham Clinton speaking at a Family Circle Luncheon in Chicago, Illinois.

Material responsive to this case was previously processed in FOIA case numbers 2006-1135-F & 2016-0871-F.

Records that were responsive to this FOIA request were found in one collection area and one series—Clinton Presidential Records: Photographs of the White House Photograph Office and the series therein—Photographs Relating to the Clinton Administration. Processing is done at the Folder/Contact sheet level. While this method maintains folder/contact sheet integrity, it frequently results in the processing of photographs that are not wholly responsive to the subject area.
