Approximately 1,328 photographs in color and black & white film processed from 35mm negatives.

Scope and Content

FOIA 2022-0195-F is a request for all photographs taken on April 21, 1994 by White House photographers. The photographers assigned to follow the President on this day include Sharon Farmer, Ralph Alswang, Bob McNeely and Barbara Kinney. Photographers would turn in their daily rolls to the White House Photograph Office for processing and roll number assignment, meaning while images are roughly in chronological order to how they were taken some minor discrepancies will be present depending on what order the material was turned in. FOIA processing for this case will maintain the integrity of the roll numbers assigned. Photographs processed for April 21, 1994, are as follows:

President Clinton jogging on the National Mall in Washington, DC., Hillary Rodham Clinton meeting in the West Wing with author Sara Paretsky, who presents the First Lady with her book "Tunnel Vision," President Clinton addressing a Labor Leaders briefing in the Old Executive Office Building (EOOB), greeting representatives from Cadillac and General Motors on the South Lawn during the reception of the new Cadillac Fleetwood Brougham limousine on the South Lawn, briefing with staff in the Oval Office for an Earth Day event, addressing an Earth Day event at Meridian Hill Park in Washington, DC., meeting regarding Bosnia in the Oval Office, greeting Molly Raiser and members of the State Department Protocol staff in the Oval Office, announcing the Teacher of the Year event in the Rose Garden, greeting Cathy Zoi in the Oval Office, President Clinton and Vice President Al Gore walking down the South Lawn sidewalk, looking at jumbo display photos in the West Wing with Brad Smith and Wendy Smith, greeting representatives from the Big Brother and Big Sister organizations in the Oval Office, greeting Cheryl Duckett and Del Boyett in the Oval Office, addressing the American Academy in Rome Prix De Rome Awards ceremony in the East Room, meeting with Senator Daniel Patrick Moynihan in the Oval Office, talking alone with Pat Griffin in the Oval Office, meeting with Stephen Carter, Alexis Herman and Linda Lader in the Oval Office, meeting with Ray Flynn, U.S. Ambassador to the Vatican, in the Oval Office, walking along the colonnade with Christine Varney, Phil Caplan and Capricia Marshall, attending a Radiation Committee reception with Secretary Hazel O'Leary and Secretary Donna Shalala in the Diplomatic Reception Room, walking from the White House to Blair House with Tony Lake, George Stephanopoulos and Alexis Herman, attending a reception and greeting Prime Minister Andreas Papandreu and his wife Dimitra Liani-Papandreu at Blair House, President Clinton returning to the White House following the reception at Blair House, meeting in the Oval Office with writing staff including Mack McLarty, Mark Gearan, George Stephanopoulos, David Dreyer, Mark Katz, Don Baer and Andrew Friendly, talking alone with Betty Currie in the Outer Oval Office, Ricki Seidman talking with Alexis Herman, Linda Lader and Kelly Crawford in the Outer Oval Office, Vice President Gore talking with Christine Varney, Dianna Pierce and Phil Kaplan in the Outer Oval Office and photographer Callie Shell looking at photos on Betty Currie's desk.

System of Arrangement
