#### Scope and Content

The materials in FOIA 2018-0360-F are a selective body of documents responsive to the topic of the FOIA.

FOIA request 2018-0360-F contains photographs from January 21, 1998 of President Clinton interviewing with Jim Lehr for PBS Television "News Hour" in the Roosevelt Room, and President Clinton interviewing with Mara Liasson & Robert Seigel of National Public Radio (NPR) in the Oval Office. President Clinton discusses a wide range of topics including: Independent Counsel's Investigation, Middle East Peace, Asian Economics, U.S. Relations with Cuba, Federal Budget, Social Security and other topics.

#### System of Arrangement

Records that were responsive to this FOIA request were found in one collection area and one series—Clinton Presidential Records: Photographs of the White House Photograph Office and the series therein—Photographs Relating to the Clinton Administration. Processing is done at the Folder/Contact

sheet level. While this method maintains folder/contact sheet integrity, it frequently results in the incidental processing of photographs that are not wholly responsive to the subject area.
