Scope and Content

FOIA 2008-0666-F (Segment 2) is a request for all Clinton Administration White House photographs taken from July 1, 2000 through December 31, 2000.

The photographs processed in this segment were created from July 2, 2000 & July 4, 2000 through July 7, 2000. The segment contains photographs pertaining to: arrivals, departures, meetings, ceremonies, press briefings, interviews, photo-ops, etc., involving President Clinton, Hillary Rodham Clinton, Chelsea Clinton, staff and others for the time period processed.

Photographs from July 4, 2000 are as follows:

President William Jefferson Clinton departs Westchester County Airport en route to Columbia, Missouri. The President arrives at Columbia Regional Airport. He greets individuals on the tarmac including Governor Mel Carnahan and his wife Mrs. Jean Carnahan, and Lieutenant Governor Roger Wilson, among others.

System of Arrangement

Records that were responsive to this FOIA request were found in one collection area and one series—Clinton Presidential Records: Photographs of the White House Photograph Office and the series therein—Photographs Relating to the Clinton Administration. Processing is done at the Folder/Contact sheet level. While this method maintains folder/contact sheet integrity, it frequently results in the processing of photographs that are not wholly responsive to the subject area.
