**All Presidential series photographs from the Clinton Administration taken November 19, 2000, November 22, 2000, and November 27 through 28, 2000.**

### **Extent**

Approximately 1,870 photographs in color and black & white film processed from 35mm negatives and born-digital files.

### **Access**

Collection is open to all researchers. Access to Clinton Presidential Records is governed by the Presidential Records Act (PRA) (44 U.S.C. Chapter 22, as amended) and the Freedom of Information Act (FOIA) (5 U.S.C. 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

### **Scope and Content**

FOIA 2008-0666-F (Segment 31) is a request for all Clinton Administration White House photographs taken from July 1, 2000 through December 31, 2000.

The photographs processed in this segment were created from November 19, 2000, November 22, 2000, and November 27 through 28, 2000. The segment contains photographs pertaining to: arrivals, departures, meetings, ceremonies, photo-ops, etc., involving President Clinton, Hillary Rodham Clinton, Chelsea Clinton, staff and others for the time period processed.

**Photographs from November 19, 2000 are as follows:**

President William Jefferson Clinton delivers remarks at the United States / Vietnamese Business Forum reception in Ho Chi Minh City, Vietnam.

President William Jefferson Clinton participates in an interview with John King of CNN at the Caravelle Hotel in Ho Chi Minh City, Vietnam.

President William Jefferson Clinton and First Lady Hillary Rodham Clinton greet Consulate staff in Ho Chi Minh City, Vietnam.

President William Jefferson Clinton, First Lady Hillary Rodham Clinton, and Chelsea Clinton depart Tansonnhat International Airport in Ho Chi Minh City, Vietnam en route Elmendorf Air Force Base, Alaska. The First Family arrive at Andrews Air Force Base.

President William Jefferson Clinton helps at the Capital area community food bank along with volunteers. Present include Dan Glickman, Representative Tony Hall, Eleanor Holmes Norton, Linda Cropp, and Lynn Brantley, among others

President William Jefferson Clinton greets guests in the Oval Office at the White House. The President later signs bills, including S. 1880, Minority Health and Health Disparities Research and Education Act of 2000.

President William Jefferson Clinton participates in a taping session for Ramadan at the White House.

President William Jefferson Clinton participates in the annual Thanksgiving Turkey Pardon event at the White House. Present include Dan Glickman, Jerry Jerome, and Stuart Proctor, among others. The President holds his nephew Tyler Clinton.

President William Jefferson Clinton, First Lady Hillary Rodham Clinton, and Chelsea Clinton depart the White House for Camp David via Marine One.

**Photographs from November 27, 2000 are as follows:**

President William Jefferson Clinton greets former staffer John Emerson and his family in the Oval Office. Later, the President speaks on the telephone with President Ricardo Lagos of Chile. Present include Gene Sperling, Sandy Berger, and Arturo Valenzuela.

President William Jefferson Clinton participates in a cabinet meeting at the White House. Present include Andrew Cuomo, Dan Glickman, Larry Summers, Janet Reno, Strobe Talbott, Charlene Barshefsky, Gene Sperling, Aida Alvarez, Barry McCaffrey, Sandy Berger, Richard Riley, Bruce Babbitt, William Cohen, Rodney Slater, Hershel Gober, John Podesta, Alexis Herman, Carol Browner, Jack Lew, and Bruce Reed, among others. The press pool is also pictured in the room.

President William Jefferson Clinton participates in a videotaping session in the Roosevelt Room at the White House.

President William Jefferson Clinton delivers remarks at the Dan Dutko Foundation Dinner at The Palm in Washington, DC.

President William Jefferson Clinton and First Lady Hillary Rodham Clinton address the White House Conference on Culture and Diplomacy. Present include Madeleine Albright, Prince Karim Aga Khan IV, Joan Spero, Rita Dove, Ole Soyinka, Yo-Yo Ma, and Giovanna Melandri, among others.

First Lady Hillary Rodham Clinton participates in separate interviews with Jane Clayson, Robin Roberts, Katie Couric, Kathy Kiely, and Diane Rehm at the White House.

**System of Arrangement**

Records that were responsive to this FOIA request were found in one collection area and one series—Clinton Presidential Records: Photographs of the White House Photograph Office and the series therein—Photographs Relating to the Clinton Administration. Processing is done at the Folder/Contact sheet level. While this method maintains folder/contact sheet integrity, it frequently results in the processing of photographs that are not wholly responsive to the subject area.
