Scope and Content

FOIA 2008-0666-F (Segment 5) is a request for all Clinton Administration White House photographs taken from July 1, 2000 through December 31, 2000.

The photographs processed in this segment were created from July 13, 2000, July 23, 2000 and July 25, 2000 through July 26, 2000. The segment contains photographs pertaining to: arrivals, departures, meetings, ceremonies, press briefings, interviews, photo-ops, etc., involving President Clinton, Hillary Rodham Clinton, Chelsea Clinton, staff and others for the time period processed.
