Scope and Content

The materials in FOIA 2019-0175-F are a selective, not necessarily all inclusive, body of photographs responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

The request consists of photographs regarding the Clinton's visit to Kigali, Rwanda on March 25, 1998 (Including the flight to and from Kigali, Rwanda). All events are from March 25, 1998 and include: President Clinton and Hillary Rodham Clinton depart Uganda and travel to Rwanda via Air Force One, President Clinton makes a statement to reporters on the tarmac at Entebbe, Uganda regarding a school shooting in Jonesboro, Arkansas, President Clinton and Hillary Rodham Clinton arrive at Kigali Airport in Rwanda, President Clinton meets with President Bizimungu of Rwanda at the Kigali Airport, President Clinton, Hillary Rodham Clinton and the U.S. Delegation participate in a discussion with Genocide survivors and future builders at Kigali Airport (Members of the U.S. Delegation include: Rev. Jesse Jackson, Sandy Berger, Rep. Maxine Waters, Rep. Charles Rangel, Susan Rice and others),

President Clinton delivers remarks honoring Rwandan Genocide survivors at Kigali Airport, President Clinton, Hillary Rodham Clinton, President Bizimungu and others dedicate a sculpture at the Kigali Airport in memory of the victims of the Rwandan Genocide, The Clintons and President Bizimungu depart Kigali via Air Force One for Entebbe, Uganda and President Clinton and Hillary Rodham Clinton talk with staff and guests during their flight to Uganda.

Other events that were included on the responsive photo contact sheets include:

March 25, 1998: President Clinton greets U.S. Marines next to Marine One at the Landing Zone in Kampala, Uganda, President Clinton participates in the Entebbe Summit for Peace and Prosperity at the Imperial Botanical Beach Hotel in Entebbe, Uganda

System of Arrangement

Records that were responsive to this FOIA request were found in one collection and one series—Clinton Presidential Records: Photographs of the White House Photograph Office and the series therein—Photographs Relating to the Clinton Administration. Processing is done at the Folder/Contact sheet level.
