#### Scope and Content

The materials in FOIA 2017-1266-F are a selective body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related material.

Photographs for FOIA 2017-1266-F include events from September 6, 2000 and September 7, 2000.

Photographs from September 6, 2000 include the following events: President Clinton meets with President Vladimir Putin at the Waldorf-Astoria Hotel in New York, NY; President Clinton and President Putin sign the Joint Statement on Strategic Stability Cooperation Initiative between the United States and the Russia Federation at the Waldorf-Astoria Hotel; President Clinton and Chelsea Clinton arrive at the United Nations for the U.N. Millennium Summit in New York, President Clinton has a pull-aside meeting with President Tran Duc Long of Vietnam in the Indonesian Lodge at the United Nations; President Clinton greets Waldorf-Astoria Hotel personnel; President Clinton attends a luncheon hosted by United Nations Secretary General Kofi Annan at the United Nations.

Photographs from September 7, 2000 include the following events: President Clinton attends a luncheon for the five permanent members of the United Nations Security Council at the Waldorf Astoria Hotel (Leaders include: Prime Minister Tony Blair, United Kingdom of Great Britain and Northern Ireland; President Jiang Zemin, China; President Jacques Chirac, France and President Vladimir Putin, Russia); President Clinton meets with Sec. Madeleine Albright, Sandy Berger, Wendy Sherman, Ambassador Richard Holbrooke, Steve Ricchetti and others prior to meeting President Kim Dae-Jung of Korea at the Waldorf-Astoria Hotel; President Clinton meets with President Kim Dae-Jung of South Korea at the Waldorf-Astoria Hotel; President Clinton has a pull-aside meeting with President Ben Ali of Tunis at the United Nations in New York; President Clinton visits with Prime Minister Tony Blair, his wife Cherie Blair and their infant son in New York; White House Military Aide Charles Williams poses for a photo with a Naval officer at the Waldorf-Astoria Hotel

### **System of Arrangement**

Records that were responsive to this FOIA request were found in one collection area and one series—Clinton Presidential Records: Photographs of the White House Photograph Office and the series therein—Photographs relating to the Clinton Administration. Processing is done at the Folder/Contact sheet level. While this method maintains folder/contact sheet integrity, it frequently results in the incidental processing of photographs that are not wholly responsive to the subject area.
