Approximately 1,573 photographs in color and black & white film processed from 35mm negatives.

Scope and Content

FOIA 2016-0984-F (Segment 38) is a request for all Clinton Administration White House photographs taken from January 1, 1994, through December 31, 1994. All the photo contact sheets reviewed in this segment are from dates April 22, 1994, through April 24, 1994. A significant amount of the photo contact sheets in this segment were previously processed in case 2022-0196-F. The finding aid inventory will reflect the previously processed photo contact sheets.

The photographs processed in this segment contains photographic events pertaining to arrivals, departures, meetings, ceremonies, press briefings, interviews, photo-ops, etc., involving President William Jefferson Clinton, First Lady Hillary Rodham Clinton, White House Staff, and others for the time period processed.

Photographs proposed to be released from April 22, 1994, are as follows:

President Clinton and Eli Segal address the National Volunteer Action Awards Ceremony in the Rose Garden. President Clinton presents awards to honorees at the ceremony. President Clinton greets ceremony guests including Edward James Olmos and others.

President Clinton tapes his weekly radio address and Pledge of Allegiance in the Roosevelt Room. President Clinton greets radio address guests including, Bruce Reed and family, Tim Russert, and others in the Oval Office.

President Clinton confers with Secretary Warren Christopher, George Stephanopoulos, Sandy Berger, Jane Holl, and others in the Oval Office prior to his meeting with Prime Minister Andreas Papandreou of Greece.

President Clinton meets Vice President Albert Gore and with advisors including Tony Lake, David Gergen, and others in the Green Room prior to his press conference with Prime Minister Andreas Papandreou of Greece. President Clinton and Prime Minister Papandreou of Greece look at the Rose Garden and White House from the Colonnade. Bob Boorstin confers with David Dreyer in the Red Room prior to the President's press conference. President Clinton and Prime Minister Papandreou participate in a press conference in the East Room. President Clinton escorts Prime Minister Papandreou and his wife Dimitra Liani through the Grand Foyer to the North Portico.

First Lady Hillary Rodham Clinton talks alone with Maggie Williams in the Red Room prior to her press conference. The First Lady gives a press conference to discuss Whitewater and financial investments in the East Room. The First Lady answers questions from reporters at her press conference.

President Clinton and First Lady Hillary Rodham Clinton greet members of the Cabinet and staff on the Truman Balcony prior to a reception and dinner at the White House. Guests include: Vice President Gore, Tipper Gore, Laura Tyson, Secretary Lloyd Bentsen, Secretary Richard Riley, Secretary Federico Pena, Secretary Robert Reich, Secretary Mike Espy, Secretary Jesse Brown, Secretary Henry Cisneros, Secretary Bruce Babbitt, Secretary Donna Shalala, Secretary Hazel O'Leary, Ambassador Madeleine Albright, Secretary Ron Brown, Director Lee Brown,
