Extent

Approximately 474 photographs in color and black & white film processed from 35mm negatives.

Access

Scope and Content

FOIA 2016-0985-F (Segment 1) is a request for all Clinton Administration White House photographs taken from January 1, 1995 through December 31, 1995.

The photographs processed in this segment were created on January 1, 1995 through January 3, 1995. The segment contains photographs pertaining to arrivals, departures, photo-ops, etc., involving President William Jefferson Clinton, First Lady Hillary Rodham Clinton, White House Staff, and others for the time period processed.

Most of the material responsive to this FOIA case & segment were previously processed in FOIA case 2016-0984-F.

Photographs from January 1, 1995 are as follows:

President William Jefferson Clinton poses with joggers for a group photograph opportunity in Hilton Head, South Carolina.

President William Jefferson Clinton walks with Tom Schneider in Hilton Head, South Carolina. Later the President is photographed with Woody Morcott, Michael Porter, and Schneider golfing.

President William Jefferson Clinton greets guests at the Marine One Landing Zone in Hilton Head, South Carolina prior to departure. The President & First Lady Hillary Rodham Clinton disembark Marine One at Beaufort Marine Corps Air Station and enter Air Force One. Also photographed is Chelsea Clinton.

Photographs from January 2, 1995 are as follows:

President William Jefferson Clinton & First Lady Hillary Rodham Clinton cross the South Lawn of the White House and board Marine One. Present with the Clintons aboard Marine One is Ginny Terzano. The Clintons disembark Marine One at Andrews Air Force Base and enter Air Force One. Present aboard Air Force One includes Marsha Scott, Ann McCoy, Robyn Dickey, Rodney Slater, and Hershel Gober. The Clintons greet guests on the tarmac at Adams Field in Little Rock, Arkansas upon arrival.

President William Jefferson Clinton & First Lady Hillary Rodham Clinton go for a walk in the Hillcrest area of Little Rock, Arkansas.

President William Jefferson Clinton & First Lady Hillary Rodham Clinton address an event at the Little Rock Convention Center. The President greets Lisa Cornwell following the event. Also photographed is Kelly Craighead with the First Lady.

Photographs from January 3, 1995 are as follows:

President William Jefferson Clinton speaks to the press in Cotton Plant, Arkansas following a hunting expedition.

Miscellaneous photographs include Kelly Crawford, Amy Harris, and Elliot Fruitkin at the White House.

System of Arrangement

Records that were responsive to this FOIA request were found in one collection area and one series—Clinton Presidential Records: Photographs of the White House Photograph Office and the series therein—Photographs Relating to the Clinton Administration. Processing is done at the Folder/Contact sheet level. While this method maintains folder/contact sheet integrity, it frequently results in the processing of photographs that are not wholly responsive to the subject area.
