#### **Extent**

Approximately 994 photographs in color and black & white film processed from 35mm negatives.

#### **Access**

Collection is open to all researchers. Access to Clinton Presidential Records is governed by the Presidential Records Act (PRA) (44 U.S.C. Chapter 22, as amended) and the Freedom of Information Act (FOIA) (5 U.S.C. 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

#### **Scope and Content**

FOIA 2016-0984-F (Segment 27) is a request for all Clinton Administration White House photographs taken March 24, 1994, through March 26, 1994; March 28, 1994. The majority of photos in this segment were processed in previously released FOIA cases 2016-0871-F & 2022-0193-F.

The photographs processed in this segment contains photographic events pertaining to arrivals, departures, meetings, ceremonies, press briefings, interviews, photo-ops, etc., involving

President William Jefferson Clinton, First Lady Hillary Rodham Clinton, White House Staff, and others for the time period processed.

**Photographs from March 24, 1994, are as follows:**

President Clinton and First Lady Hillary Rodham Clinton drive in a golf cart before departing Fisher Island for Miami, Florida. President Clinton greets people prior to departing for Miami.

President Clinton and First Lady Hillary Rodham Clinton greet hotel personnel and others at the Sheraton Hotel in Miami following a Democratic National Committee (DNC) dinner at the hotel.

First Lady Hillary Rodham Clinton participates in a Democratic Study Group on Capitol Hill in Washington, D.C.

President Clinton and First Lady Hillary Rodham Clinton attend a Senate Democratic Policy Committee luncheon on Capitol Hill in Washington, D.C. The Clintons talk to Senator Edward "Ted" Kennedy and Senator Harris Wofford at the luncheon.

President Clinton signs the Greek Independence Day Proclamation in the Oval Office. President Clinton greets ceremony guests in the Oval Office.

President Clinton greets Stephanie Streett in the Outer Oval Office. President Clinton talks with Vice President Albert Gore and Marsha Scott in the Outer Oval Office.

First Lady Hillary Rodham Clinton participates in a satellite media tour in the Old Executive Office Building (OEOB) studio. The First Lady participates with media affiliates from a wide range of cities. The First Lady greets video production assistants in the studio.

White House Photographer Bob McNeely poses for a group photo with Indian Tribe Leaders in the West Wing of the White House.

President Clinton greets Melinda Bates and Robyn Dickey in the Diplomatic Reception Room.

President Clinton makes brief remarks to reporters in the press pool prior to departing the South Grounds for Pope Air Force Base, North Carolina. President Clinton arrives at Andrews Air Force Base via Marine One for his departure to North Carolina.

President Clinton talks with General Gordon Sullivan, and others on Air Force One during the flight to Pope Air Force Base.

President Clinton arrives at Pope Air Force Base in North Carolina. The President is met by General William Steele, U.S. Army Commander of the 82<sup>nd</sup> Airborne Division Fort Bragg. President Clinton and General Steele stand at attention for a military honor guard on the tarmac.

President Clinton talks to reporters from the press pool outside the Womack Army Hospital at Fort Bragg, North Carolina.

President Clinton visits the aircraft runway crash site at Pope Air Force Base.

President Clinton talks with Representative Charlie Rose, General William Steele, and others prior to departing Pope Air Force Base.

First Lady Hillary Rodham Clinton talks alone with Bernard "Bernie" Nussbaum in the Diplomatic Reception Room. Chelsea Clinton joins the First Lady and Bernard Nussbaum, and they pose for photos before leaving the room.

Ellen Pena and her children, Nelia Joan, and Cristina Lucila pet Socks the cat on the White House Colonnade.

**System of Arrangement**

Records that were responsive to this FOIA request were found in one collection area and one series—Clinton Presidential Records: Photographs of the White House Photograph Office and the series therein—Photographs Relating to the Clinton Administration. While this method maintains folder/contact sheet integrity, it frequently results in the processing of photographs that are not wholly responsive to the subject area.
