Extent

Approximately 71 photographs in color film processed from 35mm negatives.

Scope and Content

FOIA 2016-0984-F (Segment 102) is a request for all Clinton Administration White House photographs taken October 25, 1994, through October 28, 1994. The majority of photo contact sheets in this segment from October 25, 1994, through October 28, 1994, were previously processed in case 2016-0242-F. The Finding Aid inventory will reflect the previously processed photo contact sheets.

The Clinton Presidential records to be opened consist of photographs pertaining to events listed below.

Photographs proposed to be released from October 25, 1994, are as follows:

President Clinton and First Lady Hillary Rodham Clinton visit the Tomb of the Unknown Soldiers and the Tomb of Anwar Sadat in Cairo, Egypt. The President participates in a wreath laying ceremony at the Tomb. The Clintons are accompanied by President Hosni Mubarak and First Lady Suzanne Mubarak at the ceremony.

Photographs proposed to be released from October 26, 1994, are as follows:

Portrait style views of an Israeli photographer in Aqaba, Jordan.

System of Arrangement

Records that were responsive to this FOIA request were found in one collection area and one series—Clinton Presidential Records: Photographs of the White House Photograph Office and the series therein—Photographs Relating to the Clinton Administration.
