Scope and Content

FOIA 2016-0984-F (Segment 26) is a request for all Clinton Administration White House photographs taken from January 1, 1994 through December 31, 1994.

The photographs processed in this segment were created from March 21, 1994 through March 24, 1994. The segment contains photographs pertaining to arrivals, departures, meetings, ceremonies, press briefings, interviews, photo-ops, etc., involving President William Jefferson Clinton, First Lady Hillary Rodham Clinton, White House Staff and others for the time period processed.

Many images in this case were processed in FOIA # 2022-0193-F, which includes all images from March 24, 1994.

President William Jefferson Clinton addresses a reception in the Blue Room of the White House. Present includes Attorney General Janet Reno, Lloyd Cutler, and Thomas "Mack" McLarty, among others.

First Lady Hillary Rodham Clinton meets with Eli Segal & Shirley Segawa in the Map Room of the White House. Later the First Lady meets with Steven Asher in the Map Room.

First Lady Hillary Rodham Clinton is presented with the Social Justice award from United Auto Workers President Owen Bieber at the Sheraton Hotel in Washington, DC.

First Lady Hillary Rodham Clinton arrives at the Royal Netherlands residence in Washington, DC for the celebration of tulips. Photographed includes Ambassador Adriaan Jacobovits de Szeged, Arnold Parzer, Hildebrandt Van Eeden, Marcel Wolterinck, and Fans Hulsman, among others.

Photographed includes Representative Dan Rostenkowski, Representative Pat Schroeder, Representative Marjorie Margolies-Mezvinsky, Representative Dan Hamburg, Representative David Bonior, Representative Lynn Schenk, Representative Charles Wilson, Representative Rosa DeLauro, Stan Greenberg, and Steve Ricchetti, among others. The President is informed by Jim Reed of the assassination of Luis Donaldo Colosio, Presidential candidate in Mexico. The President proceeds to the Green Room. Photographed includes Representative David Bonior, Representative Tom Foley, Pat Griffin, Susan Brophy, Karen Hancox, Lorraine Miller, and Rahm Emanuel.

President William Jefferson Clinton and Vice President Al Gore, Jr., meet with Representative Tony Hall in the Oval Office.

President William Jefferson Clinton participates in a conference call in the Oval Office to announce the Defense Diversification Program (DDP) grant.

President William Jefferson Clinton participates in taping sessions in the Map Room of the White House. Present includes Dave Anderson, Jonathan Prince, and Dianna Pierce, among others.

President William Jefferson Clinton meets with Steve Silverman, Marcia Hal, Phil Lader and David Lane in the Oval Office. Later, the President greets Bobby Wood and Tommy Caplan.

President William Jefferson Clinton greets individuals along West Executive Avenue and in the Old Executive Office Building. Present is Bob Boorstin. The President proceeds to a satellite event to the California Medical Association and converses on the telephone. Present are Bob Boorstin and Walter Zelman.

President William Jefferson Clinton speaks on the telephone with British Prime Minister John Major. Also present are Nancy Soderberg and Jane Holl. The President converses with Betty Currie. Following his conversation, the President meets with Senator John Breaux, Representative William Jefferson, Senator John Bennett Johnston, Representative James Hayes, Representative Cleo Fields, and Mayor of New Orleans Marc Morial. Following events in the Oval Office the President converses with Ricki Seidman and Jonathan Price in the Outer Oval Office.

First Lady Hillary Rodham Clinton arrives at the Rayburn Building on Capitol Hill. Present are Representative David Bonior, Representative Richard Gephardt, and Kathy Gardner (Executive Director of HealthRight). The First Lady addresses a health care event. Also photographed includes Representative Ron Wyden, Representative Tom Foley, and Arthur Fleming (Chairman of HealthRight).

First Lady Hillary Rodham Clinton speaks with Nancy Hernreich & Capricia Marshall in the Outer Oval Office of the White House. Later the First Lady speaks with Henry Aaron in the West Wing.

Ron Howard is photographed at the White House and in the Oval Office.

System of Arrangement

Records that were responsive to this FOIA request were found in one collection area and one series—Clinton Presidential Records: Photographs of the White House Photograph Office and the series therein—Photographs Relating to the Clinton Administration. Processing is done at the Folder/Contact sheet level. While this method maintains folder/contact sheet integrity, it frequently results in the processing of photographs that are not wholly responsive to the subject area.
