



## **Inventory for FOIA Request 2016-0984-F AV Segment 14 (1994, P12400-P12499)**

**All Presidential series photographs from the Clinton Administration taken from February 13, 1994 through February 16, 1994.**

### **Extent**

Approximately 2,420 photographs in color and black & white film processed from 35mm negatives.

### **Access**

Collection is open to all researchers. Access to Clinton Presidential Records is governed by the Presidential Records Act (PRA) (44 U.S.C. Chapter 22, as amended) and the Freedom of Information Act (FOIA) (5 U.S.C. 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

### **Scope and Content**

FOIA 2016-0984-F (Segment 14) is a request for all Clinton Administration White House photographs taken from January 1, 1994 through December 31, 1994.

The photographs processed in this segment were created from February 13, 1994 through February 16, 1994. The segment contains photographs pertaining to arrivals, departures, meetings, ceremonies, press briefings, interviews, photo-ops, etc., involving President Clinton, Hillary Rodham Clinton, White House Staff and others for the time period processed. Of note is a trip to Norway for the 1994 Winter Olympics, and events regarding the crime bill & health care legislations.

Additional records responsive to this case were processed in FOIA case number 2020-0378-F.

**Photographs from February 13, 1994 are as follows:**

First Lady Hillary Rodham Clinton attends the men's downhill skiing event at the Kvitfjell Ski Resort in Lillehammer, Norway.

First Lady Hillary Rodham Clinton and Chelsea Clinton go skiing in Lillehammer, Norway. Present also are Capricia Marshall, Lisa Caputo, and Kelly Craighead.

**Photographs from February 14, 1994 are as follows:**

President William Jefferson Clinton meets with Nancy Soderberg and Mandy Grunwald at the White House. The President proceeds to a meeting with Mayor Edward Rendell in the Oval Office. Present include Vice President Al Gore, Jr., and Marcia Hale.

First Lady Hillary Rodham Clinton participates in an interview with Harry Smith for CBS This Morning in Lillehammer, Norway.

First Lady Hillary Rodham Clinton and Chelsea Clinton greet guests present outside the Hamar Olympiahall Speedskating rink (Vikingskipet) in Lillehammer, Norway. Present also include Tom McMillen and Florence Griffith.

First Lady Hillary Rodham Clinton and Chelsea Clinton attend the men's luge event at the Lillehammer Olympic Bobsleight and Luge Track at Hunderfossen in Lillehammer, Norway.

First Lady Hillary Rodham Clinton greets guests at Gardermoen Airport. Present include Ambassador Tom Loftus, Florence Griffith Joyner, Tom McMillen, Kathy Karpen, David Matthews, Dawn Steel, and Irby Simpkins, among others.

First Lady Hillary Rodham Clinton greets U.S. embassy personnel, hotel staff, and volunteers at the Nevra Hotel in Lillehammer, Norway. Also present includes Ambassador Tom Loftus. Later the First Lady greets individuals present outside the hotel.

First Lady Hillary Rodham Clinton and Chelsea Clinton depart Oslo, Norway en route Andrews Air Force Base. Also present are the United States' delegation including Melanne Verveer, Lisa Caputo, Capricia Marshall, Kelly Craighead, and Barbara Kinney.

First Lady Hillary Rodham Clinton and Chelsea Clinton arrive at Andrews Air Force Base. President William Jefferson Clinton is present to greet them. Others present include Kelly Craighead, David Matthews, Florence Griffith Joyner, and Tom McMillen, among others.

**Photographs from February 15, 1994 are as follows:**

President William Jefferson Clinton meets with Mack McLarty, David Gergen, and George Stephanopoulos in the Oval Office at the White House. Also photographed include Nancy Hrenreich and Jim Reed.

President William Jefferson Clinton greets guests present on the South Lawn of the White House prior to departure via Marine One en route Andrews Air Force Base. The President proceeds to Ohio. On

board the flight includes Senators John Glenn and Joseph Biden, Wendy Smith, Steve Ricchetti, Bruce Lindsey, and Jim Reed. The President arrives at Port Columbus International Airport. The President greets anti-crime activists. The President embarks upon Marine One and arrives at Madison County Airport.

President William Jefferson Clinton delivers a speech regarding the Crime Bill at the peace officer's training academy in London, Ohio.

President William Jefferson Clinton has lunch at Charlie's House of Meats in Columbus Ohio. The President also stops at Katzinger's Restaurant. Later the President greets volunteers and police in Columbus, Ohio. Present includes Senators Joseph Biden and John Glenn.

President William Jefferson Clinton disembarks Marine One at the Madison County Airport. The President departs en route Andrews Air Force Base. Upon arrival the President proceeds to Marine One en route the White House.

First Lady Hillary Rodham Clinton hosts a tea for Mrs. Sarah Nazarbayev of Kazakhstan and Dariga Nazarbayev. Present includes Paula Feeny, Gulistan Khamzaev, Akmaral Arystanbekova, and Melanne Verveer. Also photographed is Mel French.

First Lady Hillary Rodham Clinton addresses the American Legion at the Sheraton Hotel in Washington, DC. Present includes Secretary of Veterans' Affairs Jesse Brown, Albert Bruce Theisen, Helen Holcomb, and Claude Carpenter, among others.

First Lady Hillary Rodham Clinton addresses the 17<sup>th</sup> annual Health Maintenance Organization managed care policy conference at the Washington Hilton Hotel in Washington, DC. Present include Karen Ignagni, James Walworth, George Halberon, and Samuel Havens, among others. Also photographed is Lisa Caputo and Melanne Verveer.

First Lady Hillary Rodham Clinton addresses the Vista Magazine corporate achievement awards ceremony honoring the fifty best companies for Hispanic women. Present includes Fred Estrada and award recipients.

**Photographs from February 16, 1994 are as follows:**

President William Jefferson Clinton meets with staff prior to an announcement regarding Saudi Arabia. Present includes Secretary of Commerce Ron Brown, Secretary of State Warren Christopher, Secretary of Transportation Federico Peña, Tony Lake, Bob Rubin, Mack McLarty, Dee Dee Myers, Mark Gearan, and David Gergen.

President William Jefferson Clinton meets with staff including Dee Dee Myers, Mark Gearan, David Gergen, Stephanie Streett, Tony Lake, Nancy Hernreich, Susan Brophy, Anne Walley, Keith Mason, and Mack McLarty. Later the President greets General Barry McCaffrey and Jill Ann McCaffrey.

President William Jefferson Clinton meets with Mack McLarty and George Stephanopoulos in the Oval Office. The President and First Lady Hillary Rodham Clinton greet staff and guests on the South Lawn of the White House. The President and First Lady board Marine One en route Newark, New Jersey. Also

photographed includes Sharon Farmer, Robert McNeely, Robyn Dickey, and Melinda Bates, among others.

President William Jefferson Clinton and First Lady Hillary Rodham Clinton greet police and others present in Newark, New Jersey following departure from Air Force One. The President and First Lady proceed to Middlesex County College for an event on health care. The President and First Lady converse with staff prior to the event. The First Lady delivers remarks regarding the Clinton health care plan.

President William Jefferson Clinton and First Lady Hillary Clinton greet police, volunteers, and others prior to departing from New Jersey. The President and First Lady embark on Air Force One. The President and First Lady walk to Marine One on their return from New Jersey en route the White House. Also photographed includes Kelly Craighead and Josh King.

### **System of Arrangement**

Records that were responsive to this FOIA request were found in one collection area and one series—Clinton Presidential Records: Photographs of the White House Photograph Office and the series therein—Photographs Relating to the Clinton Administration. Processing is done at the Folder/Contact sheet level. While this method maintains folder/contact sheet integrity, it frequently results in the processing of photographs that are not wholly responsive to the subject area.
