Scope and Content

FOIA 2016-0984-F (Segment 45) is a request for all Clinton Administration White House photographs taken May 10, 1994, through May 14, 1994. All the photo contact sheets reviewed in this segment are from dates May 11, 12, and 14, 1994. Numerous photo contact sheets in this segment were previously processed in cases 2023-0675-F, 2022-0197-F, and 2009-0442-F. The Finding Aid inventory will reflect the previously processed photo contact sheets.

The photographs processed in this segment contains photographic events pertaining to arrivals, departures, meetings, ceremonies, press briefings, interviews, photo-ops, etc., involving President William Jefferson Clinton, First Lady Hillary Rodham Clinton, White House Staff, and others for the time period processed.

Photographs from May 11, 1994, are as follows:

Marvin Hamlisch and guests visit the Oval Office and jokes with Dee Dee Myers and Mark Gearan. Marvin Hamlisch greets Chad Griffin in the Oval Office.

President Clinton and First Lady Hillary Rodham Clinton arrive at the U.S. Botanic Garden to attend the National Garden Gala, "A Tribute to America's First Ladies" in Washington, D.C. The First Ladies, including Lady Bird Johnson, Rosalynn Carter, Betty Ford, Nancy Reagan, Barbara Bush, gather prior to the event. Phyllis George, Merv Griffin, and others are present at the gathering prior to the gala. The First Lady and President Clinton address the gala.

President Clinton and Attorney General Janet Reno meet in the Oval Office with Rahm Emanuel, Jonathan Prince, Bruce Reed, Dee Dee Myers, Marcia Hale, and Wendy Smith. President Clinton joins Attorney General Janet Reno in the Roosevelt Room for a telephone call to U.S. Mayors. The conference call with U.S. Mayors is for a grant announcement.

President Clinton meets in the Oval Office with Sandy Berger and Jenonne Walker. They are joined by Tony Lake and other foreign policy advisers. President Clinton talks with Tony Lake and Madeleine Albright near the doorway of the Oval Office. President Clinton talks with Mack McLarty in the Oval Office.

President Clinton meets in the Oval Office with Tony Lake, George Stephanopoulos, Richard Clarke, Global Issues and Multilateral Affairs, National Security Council (NSC), and Keith Hahn, Defense Policy and Arms Control, NSC.

President Clinton meets in the Oval Office with parents whose sons who were killed after their helicopters were shot down in Somalia in 1993. James and Caroline Smith, Gail and Larry Joyce, and Tony Lake are present in the Oval Office.

President Clinton greets Charlie Trie in the Oval Office.

Photographs from May 12, 1994, Continued:

President Clinton stands in the hallway of the ground floor residence and talks with James Carville, George Stephanopoulos, and Bruce Lindsey. The group walks along the White House Colonnade and stop and chat outside the Oval Office.

President Clinton participates in video recordings in the White House Library for: President's Committee on Disabilities, Housing & Urban Development (HUD) "Stop the Fire," Ed Rendell/Police Athletic League, Asian Pacific Dinner, USC Film School Anniversary, Ely Calloway's Birthday, AFSCME District 37 50th Anniversary (New York City), and "In a New Light" ABC AIDS Special.

President Clinton and First Lady Hillary Rodham Clinton host a reception in the State Dining Room prior to attending Barbra Streisand's concert at USAir Arena in Landover, Maryland. Views of tables set for the reception. Guests include Phyllis George, Secretary Donna Shalala, Mark Gearan, Jeff Eller, Allan Stone, Ira Magaziner, Secretary Robert Reich, and Donna McLarty. President Clinton talks with George Stephanopoulos and Lloyd Cutler at the reception. The First Lady talks with Capricia Marshall, Lisa Caputo, and Ann Stock in the Cross Hall of the White House.

First Lady Hillary Rodham Clinton talks with people during intermission at the Barbra Streisand concert at USAir Arena. The Clintons meet backstage with Barbra Streisand following her concert. Guests backstage include Marvin Hamlisch, Marty Erlichman, Marilyn Bergman, Richard Baskin, Mary Chapin-Carpenter, Secretary Donna Shalala, Ken Sunshine, and others. The First Lady talks alone with Barbra Streisand backstage. The President and Barbra Streisand are served pizza from Geppetto's backstage.

President Clinton talks with Lloyd Cutler, Bruce Lindsey, Joel Klein, and Mack McLarty in the Diplomatic Reception Room after returning from the Barbra Streisand concert.

Photographs from May 14, 1994, are as follows:

The President and Governor Bayh greet former Vice President Dan Quayle at the golf course. President Clinton stops by a lemonade stand at the golf course. President Clinton drives a golf cart and greets people at the golf course.

President Clinton works on his speech with Bruce Lindsey, Mark Gearan, Carolyn Curiel, and others for the Jefferson-Jackson Day Luncheon at the Indiana Convention Center in Indianapolis. President Clinton addresses the Jefferson-Jackson Day Luncheon. Event participants include Governor Evan Bayh, Susan Bayh, and others. President Clinton talks on the telephone to former President Jimmy Carter after the luncheon. President Clinton talks with Ethel Kennedy and greets staff including Barbara Kinney and Jeff Eller following the luncheon.

President Clinton greets people at Indianapolis International Airport prior to departing for Andrews Air Force Base. President Clinton makes a presentation to Major Leo Mercado during the flight.

System of Arrangement

Records that were responsive to this FOIA request were found in one collection area and one series—Clinton Presidential Records: Photographs of the White House Photograph Office and the series therein—Photographs Relating to the Clinton Administration. Processing is done at

the Folder/Contact sheet level. While this method maintains folder/contact sheet integrity, it frequently results in the processing of photographs that are not wholly responsive to the subject area.
