Scope and Content

FOIA 2023-0026-F is a request for all Clinton Administration White House photographs relating to Copenhagen, Denmark. The time period for the events is from July 11, 1997 through July 12, 1997. Events include an arrival at Kastrup Airport, arriving at Fredensborg Palace, recording a radio address at Fredensborg Palace, addressing the public in Nytorv Square, arriving at the Margrethe Salon in the Hotel Store Kro, meeting at the Christianborg Palace, laying a wreath at Mindenluden Memorial Park, and at a luncheon at Fredensborg Palace.

Photographed includes President William Jefferson Clinton, Queen Margrethe II, Crown Prince Federieck, Prince Consort Henrieck, Prime Minister Poul Nyrup Rasmussen, Lone Dybkjaer, Ambassador Edward Elson, Suzanne Elson, Sandy Berger, Jim Steinberg, Mike McCurry, Nancy Hernreich, Doug Sosnik, Don Baer, Sylvia Mathews, Bruce Lindsey, Stephen Goodin, Kirk Hanlin, Mary Mel French, Sandy Vershbow, and Helen Thomas, among others.

System of Arrangement

Records that were responsive to this FOIA request were found in one collection area and one series—Clinton Presidential Records: Photographs of the White House Photograph Office and the series therein—Photographs Relating to the Clinton Administration.
