Scope and Content

FOIA 2016-0984-F (Segment 44) is a request for all Clinton Administration White House photographs taken from January 1, 1994 through December 31, 1994.

The photographs processed in this segment were created from May 9, 1994 through May 10, 1994. The segment contains photographs pertaining to arrivals, departures, meetings, ceremonies, press briefings, interviews, photo-ops, etc., involving President William Jefferson Clinton, First Lady Hillary Rodham Clinton, White House Staff, and others for the time period processed.

Images responsive to this segment were previously processed in FOIA case number 2023-0675-F.

Photographs from May 9, 1994 are as follows:

President William Jefferson Clinton boards Air Force One at Andrews Air Force Base. The President proceeds to John F. Kennedy International Airport in New York, New York. The President meets with staff on the flight including Ira Magaziner, Don Baer, Meeghan Prunty, Jeff Eller, Harold Ickes, and Bruce Lindsey. Upon arrival the President greets Mayor Rudolph Giuliani.

President William Jefferson Clinton visits the store Pathmark in New York, New York. The President walks through aisles and greets employees. The President makes brief remarks. Also photographed are Senator Daniel Patrick Moynihan, Kirk Hanlin, Harold Ickes, Wendy Smith, Bruce Lindsey, and Dee Dee Myers, among others.

President William Jefferson Clinton proceeds to the New York Hilton Hotel in New York, New York. The President greets policemen present. The President addresses the Association for a Better New York. Lou Rudin introduces the President. Later the President greets health care letter writers at the hotel. The President proceeds to a health care reporters roundtable. Staff present include Dee Dee Myers, Ira Magaziner, and Bruce Lindsey.

President William Jefferson visits a fire station where a memorial is on display for Captain John Drennan. Also present is Mayor Rudolph Giuliani.

President William Jefferson Clinton greets guests at the New York City Landing Zone. The President departs via Marine One en route John F. Kennedy International Airport. The President embarks on Air Force One en route Providence, Rhode Island. The President arrives at Green State Airport in Providence, Rhode Island. The President addresses guests present on the tarmac. Photographed includes Senator Claiborne Pell, Representative Jack Reed, Governor Bruce Sundlun, Michell Johnson, and Patrick Kennedy among others. The President walks over to the Presidential limousine where he speaks on the telephone to First Lady Hillary Rodham Clinton who is in South Africa.

President William Jefferson Clinton participates in a Ten Town Hall meeting at the WJAR-TV studio in Providence, Rhode Island. Following the town hall the President participates in a meet & greet with members of the audience. Photographed include Governor Bruce Sundlun, Representative Jack Reed, Senator Claiborne Pell, Christine Heenan, and Neal Dolan.

President William Jefferson Clinton greets guests on the tarmac at Green State Airport in Providence, Rhode Island. The President departs en route Andrews Air Force Base. Photographed includes Senator Claiborne Pell, Representative Jack Reed, Ira Magaziner, and Paul Carey.

Photographs from May 10, 1994 are as follows:

President William Jefferson Clinton participates in a scheduling briefing. Present includes Stephanie Streett, Wendy Smith, Ricki Seidman, and Mark Gearan.

President William Jefferson Clinton greets Secretary of the Democratic Caucus David Pryor at the White House.

President William Jefferson Clinton meets with Lloyd Cutler, Vicki Radd, Joel Klein, David Gergen, Phil Lader in the Oval Office of the White House. Following the meeting the President converses with Gergen, Dee Dee Myers, Bob Kyle, Marcia Hale, and Michael Waldman in the Outer Oval Office.

President William Jefferson Clinton participates in a briefing with Joan Baggett, Secretary of Labor Robert Reich, Joe Valasquez, Ricki Seidman, and Nancy Hernreich prior to the President meeting with the AFL-CIO. The President leaves the Oval Office and greets guests in the West Wing of the White House. The President proceeds to a meeting with the AFL-CIO executive council in the Diplomatic Reception Room. Photographed are Secretary Reich and Lane Kirkland. Following the meeting the President walks along the Colonnade to the West Wing with Baggett.

President William Jefferson Clinton meets in the Indian Treaty Room of the White House with Robert Rubin, Laura Tyson, and Mickey Kantor.

President William Jefferson Clinton greets guests at the White House including Jerry Jeff Walker, Bill Hybels, Mike Mills, and Daniela Bar-illan

President William Jefferson Clinton meets with Mike Lux, Christine Heenan, Wendy Smith, and Nancy Hernreich in the Oval Office of the White House prior to the President speaking to the American Nurses Association conference. The President leaves the Oval Office to proceed to the event. Also photographed is Socks the cat. The President arrives at the Hyatt Regency Hotel for the American Nurses Association conference. Present includes Ellen Sander and Virginia Trotter. The President confers with Lux, Heenan, and Smith prior to the event. Following the event, the President drops by an American Federation of Teachers event at the Hyatt Regency Hotel. The President greets Senator Ted Kennedy following the event.

President William Jefferson Clinton participates in the sixth annual National Fire and Emergency Service dinner at the Washington Hilton Hotel in Washington, DC. Representative Steny Hoyer is also present.

System of Arrangement

Records that were responsive to this FOIA request were found in one collection area and one series—Clinton Presidential Records: Photographs of the White House Photograph Office and the series therein—Photographs Relating to the Clinton Administration. Processing is done at the Folder/Contact sheet level. While this method maintains folder/contact sheet integrity, it frequently results in the processing of photographs that are not wholly responsive to the subject area.
