Scope and Content

FOIA 2016-0984-F (Segment 34) is a request for all Clinton Administration White House photographs taken April 13, 1994, through April 15, 1994.

The photographs processed in this segment contains photographic events pertaining to arrivals, departures, meetings, ceremonies, press briefings, interviews, photo-ops, etc., involving President William Jefferson Clinton, First Lady Hillary Rodham Clinton, White House Staff, and others for the time period processed.

Photographs from April 13, 1994, are as follows:

President Clinton confers with Vice President Albert Gore in the Green Room prior to the Olympic Ceremony in the East Room.

President Clinton, First Lady Hillary Rodham Clinton, and Vice President Albert Gore participate in a ceremony for 1994 U.S. Olympic athletes in the East Room of the White House. The Clintons greet the Olympians, and others individually in the Blue Room of the White House.

President Clinton and Vice President Albert Gore walk alone on the White House Colonnade.

President Clinton greets Carol Rasco and her parents in the Oval Office.

Lloyd Cutler talks with Vice President Albert Gore and Mack McLarty in the Oval Office.

President Clinton participates in a Cabinet Room meeting on China with Secretary Warren Christopher, Secretary Ron Brown, Vice President Albert Gore, Secretary Lloyd Cutler, Sandy Berger, Laura Tyson, Mack McLarty, Robert Rubin, Tony Lake, George Stephanopoulos, David Gergen, and Bowman Cutter.

President Clinton meets in the Oval Office with David Kusnet, Don Baer, and George Stephanopoulos.

President Clinton stands at his Oval Office desk and confers with Secretary Warren Christopher, Secretary William Perry, and Tony Lake. Vice President Albert Gore joins the meeting.

President Clinton greets Betty Currie and others in the Oval Office.

President Clinton, First Lady Hillary Rodham Clinton, and Vice President Albert Gore attend a dinner to honor the 1994 U.S. Olympic team in Washington, D.C. Dr. Leroy Walker presents the President and Vice President with United States Olympic Committee blazers at the dinner. President Clinton and Vice President Albert Gore address the dinner.

Photographs from April 14, 1994, are as follows:

President Clinton goes jogging at Hains Point in Washington, D.C. with U.S. Olympic athletes.

President Clinton participates in a breakfast meeting in the State Dining Room with members of Congress. Meeting participants include Secretary Warren Christopher, Representative Tom Foley, Senator George Mitchell, Secretary William Perry, Madeleine Albright, Tony Lake, Senator John Kerry, Senator Patrick Leahy, Senator Claiborne Pell, Senator Pete Domenici, Representative Richard Gephardt, Senator Larry Pressler, Sandy Berger, and George Stephanopoulos.

President Clinton delivers a press conference on the U.S. helicopter tragedy in Iraq in the Press Briefing Room of the White House.

President Clinton drops by a birthday party on Capitol Hill for Senator Robert "Bob" Dole. Guest include Elizabeth Dole, Senator Tom Harkin, Senator Paul Tsongas, Senator George Mitchell, and others.

Prime Minister Tansu Ciller of Turkey arrives at the White House. Deputy Chief of Protocol Fred Duval meets the Prime Minister at the West Wing entrance. Prime Minister Ciller signs the guestbook in the Cabinet Room. The Prime Minister visits with Secretary Warren Christopher and Secretary Lloyd Cutler on the White House Colonnade. President Clinton and Prime Minister Ciller meet in the Oval Office.

President Clinton walks along the White House Colonnade with Tony Lake and Jane Holl.

President Clinton meets in the Oval Office regarding U.S. aircraft tragedy in Iraq with Secretary William Perry, General John Shalikashvili, Tony Lake, and Sandy Berger.

President Clinton walks up the South Lawn sidewalk with Andrew Friendly and Socks the Cat follows him up the sidewalk.

First Lady Hillary Rodham Clinton arrives at North General Hospital in New York City. The First Lady tours the pediatric unit and visits with children and families. The First Lady watches a computer billing and processing for patients' demonstration given by nurses in the hospital unit. The First Lady meets with hospital administrators.

First Lady Hillary Rodham Clinton greets police and others at LaGuardia Airport in New York City prior to departing for Andrews Air Force Base.

System of Arrangement

Records that were responsive to this FOIA request were found in one collection area and one series—Clinton Presidential Records: Photographs of the White House Photograph Office and the series therein—Photographs Relating to the Clinton Administration. Processing is done at the Folder/Contact sheet level. While this method maintains folder/contact sheet integrity, it

frequently results in the processing of photographs that are not wholly responsive to the subject area.
