Scope and Content

FOIA 2016-0984-F (Segment 30) is a request for all Clinton Administration White House photographs taken from January 1, 1994 through December 31, 1994.

The photographs processed in this segment were created from April 4, 1994 through April 6, 1994. The segment contains photographs pertaining to arrivals, departures, meetings, ceremonies, press briefings, interviews, photo-ops, etc., involving President William Jefferson Clinton, First Lady Hillary Rodham Clinton, White House Staff and others for the time period processed.

Images responsive to this segment were previously processed in FOIA case number 2019-0519-F.

Photographs from April 4, 1994 are as follows:

President William Jefferson Clinton disembarks Air Force One at Burke Lakefront Airport in Cleveland, Ohio. The President proceeds to the motorcade en route Jacobs Field. The President throws out the first pitch of the Cleveland Indians baseball season at Jacobs Field in Cleveland, Ohio. The President greets Mayor Mike White, then throws the pitch to catcher Sandy Alomar. The President greets players in both the Indians dugout and Seattle Mariners dugout. The President watches the game with Indians owner Richard Jacobs and Bud Selig. Also photographed includes Wendy Smith, Andrew Friendly, Ralph Alswang, Josh King, Steve Cohen, and Dave Leavy.

President William Jefferson Clinton arrives at the Charlotte Coliseum to attend the NCAA Championship basketball game between the Arkansas Razorbacks and Duke Blue Devils. The President congratulates Arkansas players following their win. Photographed includes coach Nolan Richardson & Corliss Williamson. The President greets Kevin Costner among fans at the game.

President William Jefferson Clinton greets people present on the tarmac at Cleveland Hopkins International Airport. The President departs Cleveland en route Charlotte, North Carolina.

Photographs from April 5, 1994 are as follows:

President Clinton goes jogging in Fort Mill, South Carolina. Following his jog the President is photographed with people outside of a residence. Present is Erskine Bowles. The President proceeds to the Marine One Landing Zone for departure. The President departs en route Troy, North Carolina.

President William Jefferson Clinton arrives at the Troy Elementary School Landing Zone in Troy, North Carolina. The President greets students and people present. The President proceeds to Troy Elementary School. The President greets Principal Larry Robinson, Vice Principal Dave Wilkie, and Representative Bill Hefner. The President participates in a discussion regarding health care reform. Present includes Bob Jordan & Carrie Anderson, among others. The President participates in interviews. Present includes Wendell Anschutz, Ralph Hipp, Loretta Carroll, and Paul Serrell. Wolf Blitzer is photographed alone outside.

President William Jefferson Clinton discusses health care reform at Montgomery County Hospital in Troy, North Carolina.

President William Jefferson Clinton participates in a town hall meeting at NBC News in Charlotte, North Carolina. Prior to the event the President confers with staff. Present includes Bob Boorstin, Will Itoh, Paul Begala, David Watkins, Joel Klein, Mandy Grunwald, Jeff Eller, Mack McLarty, and Bruce Lindsey.

President William Jefferson Clinton greets people present upon departure from Charlotte Douglas International Airport in Charlotte, North Carolina. The President departs en route Andrews Air Force Base. The President arrives at Andrews.

First Lady Hillary Rodham Clinton arrives at Rochester International Airport in Rochester, New York. Photographed includes Senator Daniel Patrick Moynihan and Representative Louise Slaughter. The First Lady proceeds to the center for independent living for seniors in Rochester. The First Lady greets Kathryn McGuire, Robert McCann, Larry Naylor, and Warren Kosel. The First Lady proceeds to Rochester International Airport for departure en route Syracuse, New York. Present are Kelly Craighead, Lisa Caputo, and Melanne Verveer.

First Lady Hillary Rodham Clinton arrives at Hancock International Airport in Syracuse, New York. Present is Mayor Roy Bernardi. The First Lady proceeds to an event at Hendricks Chapel at Syracuse University. Present is Chancellor Kenneth Shaw, Dean Richard Phillips, Ethel Phillips, and Senator Daniel Patrick Moynihan. The First Lady addresses students inside the Chapel.

First Lady Hillary Rodham Clinton arrives at Syracuse University. The First Lady greets Deborah Jones, Executive Director of Northeast Parallel Architectures Center. The First Lady views computer demonstrations. Also present includes Senator Daniel Patrick Moynihan, Geoffery Fox, Frank Smith, and Dick Johnson.

First Lady Hillary Rodham Clinton greets people as she departs Hancock International Airport en route Andrews Air Force Base. Upon arrival to Andrews, the First Lady and Senator Daniel Patrick Moynihan depart.

Photographs from April 6, 1994 are as follows:

President William Jefferson Clinton, First Lady Hillary Rodham Clinton, and Vice President Al Gore, Jr., confer in the Oval Office prior to arrival of Supreme Court Justice Harry Blackmun. Also present includes Mack McLarty, Joel Klein, George Stephanopoulos, Mark Gearan, Ricki Seidman, Victoria Radd, and Tony Lake. Justice Blackmun and his wife Dorothy Blackmun enter the Oval Office. Also present are Lloyd Cutler and Phil Lader. The President and Justice Blackmun announce Blackmun's decision to retire from the Supreme Court in a ceremony in the Roosevelt Room of the White House. Following the announcement, the President & Justice Blackmun converse in the White House. Present includes David Dreyer.

First Lady Hillary Rodham Clinton attends an event at the White House for retired Chicago Cubs players. Present includes Don Cardwell, Bill Hands, Randy Hundley, Walt Moryn, Andy Pafko, Bruce Ladd, and Ernie Banks. Also present is President William Jefferson Clinton and Vice President Al Gore, Jr. The First Lady departs the White House en route the Capitol Hilton for the Eighth Biennial Luncheon of the Emil Verban Memorial Society. Seated with the First Lady is former Chicago Cubs players. Also photographed includes Stan Greenberg, Harold Ickes, Melanne Verveer, and George Stephanopoulos.

President William Jefferson Clinton prepares to depart the White House for Bowling Green, Kentucky. The President proceeds to the South Lawn Landing Zone to Marine One. On the flight via Air Force One the President confers with Secretary of Labor Robert Reich, Pat Griffin, Secretary of Health & Human Services Donna Shalala, and Mark Gearan. Air Force One arrives in Bowling Green, Kentucky.

President William Jefferson Clinton attends the funeral of Representative William Natcher at Eastwood Baptist Church in Bowling Green, Kentucky. Following the service, the President greets people outside of the Fruit of the Loom factory in Bowling Green, Kentucky.

System of Arrangement

Records that were responsive to this FOIA request were found in one collection area and one series—Clinton Presidential Records: Photographs of the White House Photograph Office and the series therein—Photographs Relating to the Clinton Administration. Processing is done at the Folder/Contact sheet level. While this method maintains folder/contact sheet integrity, it frequently results in the processing of photographs that are not wholly responsive to the subject area.
