Scope and Content

FOIA 2023-0540-F is a request for all audio/visual records relating to the funeral service and subsequent reception for President Richard Milhous Nixon. The service was held at the Richard Nixon Library & Birthplace site in Yorba Linda, California on April 27, 1994. Following the funeral service, participants proceed to a reception.

Material processed as consequence includes President William Jefferson Clinton aboard Air Force One, the President & First Lady Hillary Rodham Clinton departing Yorba Linda for El Toro Marine Base, arrival at El Toro Marine Base, and the First Lady giving an interview.

Individuals photographed include President William Jefferson Clinton, First Lady Hillary Rodham Clinton, former President Jimmy Carter, former First Lady Rosalyn Carter, former President Ronald Reagan, former First Lady Nancy Reagan, former President George H. W. Bush, former First Lady

Barbara Bush, Governor Pete Wilson, Gayle Wilson, Reverend Billy Graham, Henry Kissinger, Nancy Kissinger, Senator Robert Dole, Tricia Nixon Cox, Julie Nixon Eisenhower, George McGovern, Chuck Colson, Walter Annenberg, Leonore Annenberg, and Vernon Jordan, among others

Despite the title of this FOIA case, no video recordings were found to be responsive. Records responsive to this segment were previously processed in FOIA case number 2007-0623-F.

System of Arrangement

Records that were responsive to this FOIA request were found in one collection area and one series— Clinton Presidential Records: Photographs of the White House Photograph Office and the series therein—Photographs Relating to the Clinton Administration. Processing is done at the Folder/Contact sheet level. While this method maintains folder/contact sheet integrity, it frequently results in the processing of photographs that are not wholly responsive to the subject area.
