Scope and Content

FOIA 2023-0519-F is a request for all Clinton Administration White House photographs taken on June 9, 1997 at the White House. The events photographed include President William Jefferson Clinton participating in a scheduling meeting, the President greeting interns and participating in a photograph opportunity, the President greeting golfer Greg Norman in the Oval Office, the President meeting with international labor leaders in the Roosevelt Room, the President vetoing the Congressional Intent Bill, the President being presented the national bioethics advisory committee report in the Rose Garden, and the President being interviewed by Business Week.
