Approximately 2,472 photographs in color and black & white film processed from 35mm negatives.

Scope and Content

FOIA 2016-0984-F (Segment 76) is a request for all Clinton Administration White House photographs taken June 7, 1994; July 27, 1994; July 31, 1994, through August 3, 1994. One photo contact sheet from June 7, 1994, was previously processed in case 2022-0198-F.

The Clinton Presidential records to be opened consist of photographs pertaining to arrivals, departures, meetings, ceremonies, press briefings, official phone calls, photo-ops, etc. involving President William Jefferson Clinton, First Lady Hillary Rodham Clinton, White House Staff, and others for the time period processed.

Photographs from July 31, 1994, are as follows:

President Clinton plays golf with Senator Joe Biden and Tim Chorba at Army Navy Country Club in Arlington, Virginia.

First Lady Hillary Rodham Clinton arrives at Logan Airport in Boston, Massachusetts.

First Lady Hillary Rodham Clinton addresses a Health Care Express Rally at Faneuil Hall in Boston. Participants include Senator Edward "Ted" Kennedy, former Governor Michael Dukakis, and Folk singer Peter Yarrow.

First Lady Hillary Rodham Clinton addresses the New England Council at the Park Plaza Hotel in Boston.

First Lady Hillary Rodham Clinton greets Boston police and others at Logan Airport prior to her departure.

Photographs from August 1, 1994, are as follows:

President Clinton jogs on the National Mall in Washington, D.C.

President Clinton meets in the Oval Office with First Lady Hillary Rodham Clinton, Senator George Mitchell, Leon Panetta, and Ira Magaziner. Prior to the meeting, President Clinton confers with the First Lady, Pat Griffin, Ira Magaziner, Harold Ickes, George Stephanopoulos, and Leon Panetta in the Oval Office.

President Clinton talks with Nancy Hernreich and Betty Currie in the Outer Oval Office.

First Lady Hillary Rodham Clinton pets Socks the cat in the Outer Oval Office. In addition, Pat Griffin and Betty Currie pet Socks in the Outer Oval Office.

President Clinton signs S. 832, Designating the Federal Triangle property as "Woodrow Wilson Plaza," in the Oval Office with Senator Mark Hatfield, Senator Daniel Patrick Moynihan, and others are present. Leon Panetta talks with Pat Griffin in the Oval Office at the signing.

Photographs from August 1, 1994, Continued:

President Clinton greets staff and guests on the South Lawn prior to departing on Marine One to Andrews Air Force Base for a flight to Newark, New Jersey. President Clinton plays cards on Marine One with Dee Dee Myers and Bruce Lindsey.

President Clinton arrives at Newark International Airport. The President is greeted by Governor Christine Todd Whitman and others.

President Clinton arrives at Liberty State Park in New Jersey. President Clinton greets and talks to health care letter writers on the Park's Boardwalk regarding their health care issues. The President addresses a Health Security Express Rally at the park. President Clinton greets supporters at the Old Terminal building in the park.

President Clinton greets police and others prior to departing Newark International Airport for a flight to Andrews Air Force Base. During the flight, President Clinton talks with Josh King, Wendy Smith, Steve Rabinowitz, and Chad Griffin in the Air Force One conference room. President Clinton arrives at Andrews Air Force Base and crosses the tarmac at Andrews to board Marine One. President Clinton arrives at the White House South Lawn on Marine One.

President Clinton walks along the White House Colonnade with Harold Ickes.

President Clinton meets with Secretary William Perry and Tony Lake regarding Rwanda in the Oval Office.

President Clinton meets with Senator Charles Robb and Steve Ricchetti in the Oval Office.

President Clinton jogs along the Potomac River and the Lincoln Memorial Reflecting Pool in Washington.

Views of Socks the cat sitting on the sidewalk at the White House.

First Lady Hillary Rodham Clinton meets with Ed McMahon, Pamela McMahon, and Starlight Foundation representatives in the Diplomatic Reception Room.

President Clinton makes an announcement in the Roosevelt Room regarding revitalizing America's Merchant Marine and shipbuilding industries. Announcement participants include Secretary Federico Pena, Doug Ballis, John Dane III, Secretary Ron Brown, Mickey Kantor, and Bowman Cutter. Prior to the announcement the President meets in the Oval with announcement participants, Steve Silverman, and others. President Clinton greets shipbuilding executives in the Oval Office.

First Lady Hillary Rodham Clinton addresses a Health Professionals for Universal Coverage event with Representative Richard Gephardt at the Russell building on Capitol Hill. Participants include Virginia Betts Trotter, Senator Paul Wellstone, Senator Paul Simon, Senator Jay Rockefeller, and others. The First Lady departs the Russell building with Kelly Craighead, Lisa Caputo, and Melanne Vermeer.

President Clinton meets with Leon Panetta, George Stephanopoulos, Ricki Seidman, Harold Ickes, Mandy Grunwald, Don Baer, Mark Gearan, and Lloyd Cutler in the Cabinet Room regarding his upcoming press conference. In addition, President Clinton meets in the Cabinet Room with Harold Ickes, Mandy Grunwald, Ira Magaziner, Mark Gearan, Christine Heenan, Stan Greenberg, Lloyd Cutler, Dee Dee Myers, George Stephanopoulos, and Steve Ricchetti.

President Clinton confers in the Cabinet Room with George Stephanopoulos, John Podesta, Mark Gearan, David Dreyer, Lloyd Cutler, Gene Sperling, Todd Stern, and Dee Dee Myers.

President Clinton talks with Robert Rubin, Leon Panetta, and George Stephanopoulos in the Oval Office.

President Clinton and Secretary Henry Cisneros talk on the telephone in the Oval Office with Los Angeles Mayor Richard Riordan and Santa Monica Mayor Judy Abdo to announce California earthquake recovery relief.

President Clinton greets Michael Granoff and Darryl Gless in the Oval Office.

President Clinton meets in the Oval Office with Representative Mel Reynolds.

President Clinton meets in the Oval Office with Senator Joseph Lieberman. Mack McLarty is present at the meeting.

Views of Socks the cat lying on the sidewalk on the South Grounds of the White House.

President Clinton and First Lady Hillary Rodham Clinton address a Health Security Express event on the South Lawn of the White House. Dais participants include health care reform riders: Daniel Lumley, Carolyn Mosley, and John Cox. President Clinton wipes tears from his eyes and embraces one of the reform riders. The Health Care Express buses are parked in the South Portico driveway. The Clintons greet participants in the Diplomatic Reception Room. Prior to the event the Clintons talk with Julia Moffett, Mike Lux, Melanne Verveer, and others in the Map Room.

System of Arrangement
