#### **Extent**

Approximately 2,645 photographs in color and black & white film processed from 35mm negatives.

#### **Access**

Collection is open to all researchers. Access to Clinton Presidential Records is governed by the Presidential Records Act (PRA) (44 U.S.C. Chapter 22, as amended) and the Freedom of Information Act (FOIA) (5 U.S.C. 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

#### **Scope and Content**

FOIA 2016-0984-F (Segment 32) is a request for all Clinton Administration White House photographs taken January 27, 1993; April 7, 1994, through April 11, 1994.

The photographs processed in this segment contains photographic events pertaining to arrivals, departures, meetings, ceremonies, press briefings, interviews, photo-ops, etc., involving President William Jefferson Clinton, First Lady Hillary Rodham Clinton, White House Staff, and others for the time period processed.

**Photographs from January 27, 1993, are as follows:**

**System of Arrangement**

Records that were responsive to this FOIA request were found in one collection area and one series—Clinton Presidential Records: Photographs of the White House Photograph Office and the series therein—Photographs Relating to the Clinton Administration.
