Scope and Content

This FOIA case is a request for all photographs relating to Robert Reiner. Reiner was an accomplished actor who during the Clinton Presidency turned primarily to directing films. He frequently was present at events involving the Clintons with his wife, Michele Singer Reiner, who was a political activist.

Photographs responsive to this case were previously processed in FOIA case numbers 2008-0666-F Segment 23, 2016-0100-F Segment 6, 2016-0100-F Segment 10, 2016-0984-F Segment 25, and 2021-0260-F. Researchers should consult those cases for further responsive material.

Photographs processed in this case include a planning session luncheon in Washington, DC, on July 29, 1995, a taping session for "I Am Your Child" for ABC at the White House on March 8, 1997, the White House Conference on Early Childhood in the East Room of the White House on April 17, 1997, the Democratic Governors Association National Policy Forum on Children at the Sheraton Santa Monica hotel in Santa Monica, California on May 19, 1997, the White House Conference on Child Care on the

State Floor of the White House on October 23, 1997, an event at the Waldorf Astoria hotel in New York, New York on May 11, 1998.

System of Arrangement

Records that were responsive to this FOIA request were found in one collection area and one series—Clinton Presidential Records: Photographs of the White House Photograph Office and the series therein—Photographs Relating to the Clinton Administration. Processing is done at the Folder/Contact sheet level. While this method maintains folder/contact sheet integrity, it frequently results in the processing of photographs that are not wholly responsive to the subject area.
